to be members of the Taskforce on review of Independent Power Producers (IPPs) Power Purchase Agreements (PPAs), for a period of three (3) months, with effect from the 3rd January, 2017.

Terms and Mandate of the Taskforce

The Taskforce is set up to review the PPAs and recommend appropriate policy action that will enable Government achieve value for money on all power purchase agreements signed to date.

The Taskforce shall be required to:

1. Establish and categorize the existing PPAs by date commissioned, technology, duration, tariff and expected decommissioning date.
2. Review legislation relating to PPAs including the Constitution of Kenya, Energy Act, 2006 and draft of the Energy Bill, 2016.
3. Establish the annual revenue requirements for each PPA and for the remaining PPA period.
4. Explore if any of the thermal power IPPs could be terminated by mutual agreement by KPLC and the Developers as per the termination clause in the PPA, and compute and provide an analysis of financial requirements and implications under different scenarios of such termination, including recommending ways of mobilizing funds for the cost of such termination, if any.
5. Explore viable and amenable ways of transiting projects done under the current Feed-in Tariffs Policy to the intended Renewable Energy Auctions.
6. Undertake a comparative analysis of our generation tariff with others in the Region and Globally.
7. Recommend ways of standardizing the Power Purchase Agreement (PPA).
8. Recommend ways of introducing wheeling tariffs for PPA Transmission lines with minimal impact on retail tariff.

Powers of the Taskforce

1. The Taskforce may establish committees to address technical or other specific issues. The Taskforce will prepare the Terms of Reference of its committees. The membership of the committees will draw from the membership of the Taskforce.
2. The Taskforce and its committees may invite external experts to participate on an *ad hoc* basis in one or more of their meetings.
